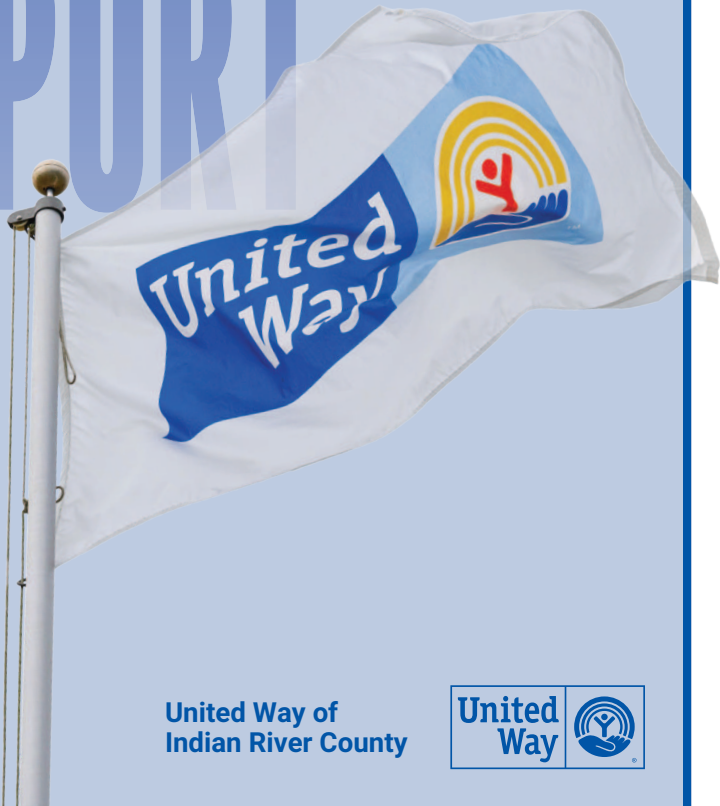

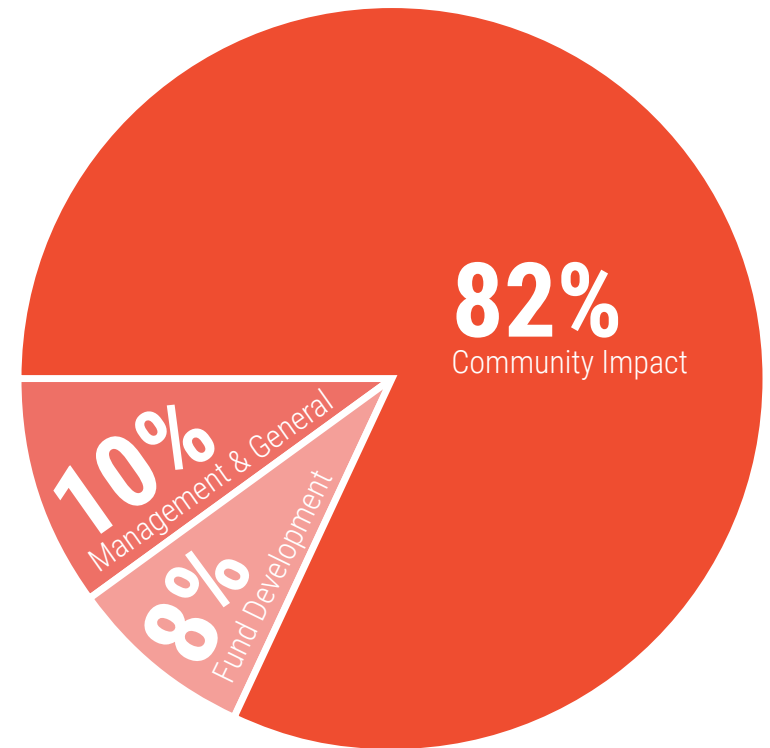
YOUR INVESTMENT MATTERS

MEET ALICE

ALICE which stands for **A**sset **L**imited, **I**ncome **C**onstrained, **E**mployed, could be someone close to you—a family member or a friend. You might even find yourself in the shoes of ALICE. Occupations like cashiers, waiters, child care providers, and many others form the backbone of our essential workforce, yet ALICE earners barely surpass the Federal Poverty Level, finding it challenging to cover their basic needs. Every day, these households confront impossible decisions due to financial strain. This struggle is widespread, with households of color disproportionately represented among ALICE demographics.

Did you know that 13% of Floridians live below the federal poverty level (FPL)?

Over 1.1 million Floridians fall below the ALICE Threshold, the income necessary for household sustenance. In Indian River County alone, nearly 31,250 residents face the challenge of making ends meet. The annual household survival budget for an individual residing in Indian River County amounts to \$27,516.

ALICE also represents the data reshaping the dialogue on financial hardship, and a grassroots movement that is picking up steam across half of U.S. states - and counting.

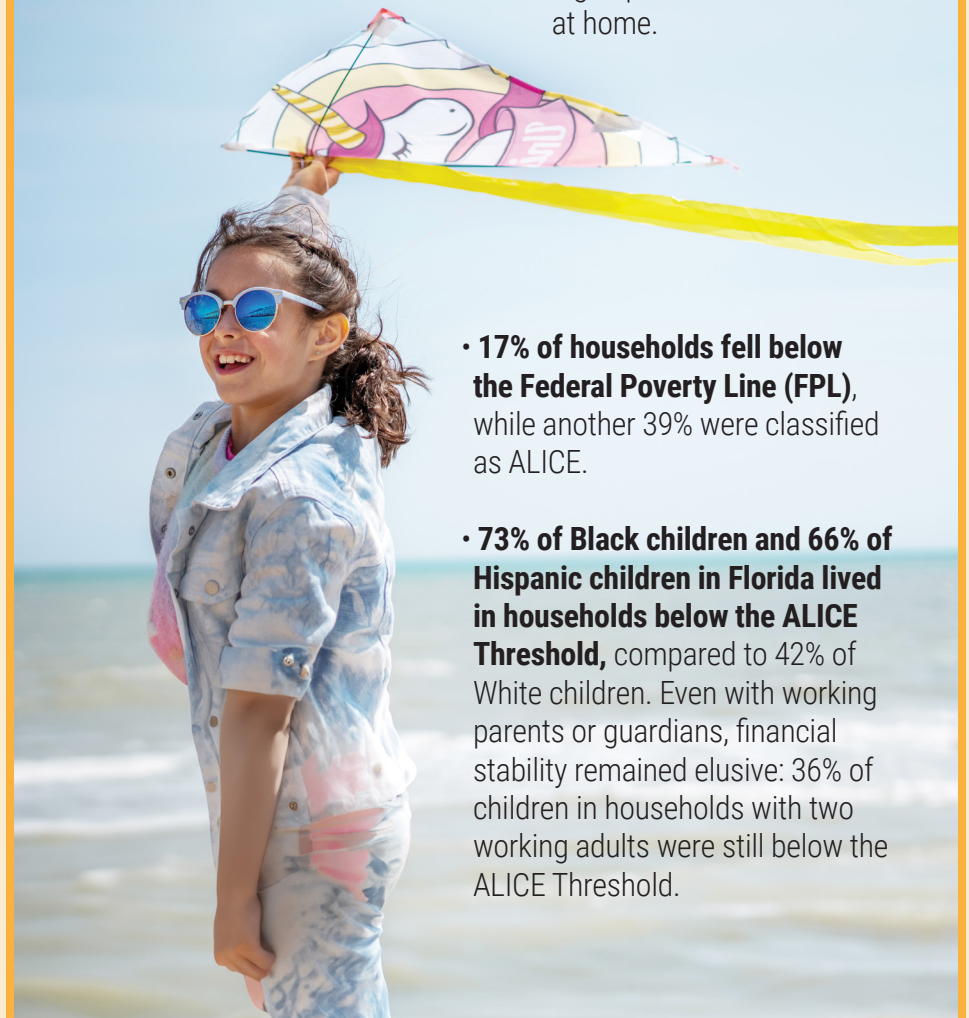

- **Children below the ALICE Threshold often lack access to resources** ranging from stable housing and public assistance to education and broadband services. Almost 1.5 million children below the ALICE Threshold in Florida did not participate in SNAP, and nearly 700,000 had no high-speed internet access at home.

- **17% of households fell below the Federal Poverty Line (FPL)**, while another 39% were classified as ALICE.

- **73% of Black children and 66% of Hispanic children in Florida lived in households below the ALICE Threshold**, compared to 42% of White children. Even with working parents or guardians, financial stability remained elusive: 36% of children in households with two working adults were still below the ALICE Threshold.

- **36% of American Indian/ Alaska Native, Black, and Hispanic veterans** in Florida lived below the ALICE Threshold, compared to 24% of Asian and 27% of White veterans.

- **57% of Florida veterans over 25 lacked postsecondary education.** Among high school graduates without post-secondary education, 35% were below the ALICE Threshold.

- **Veterans with disabilities in Florida faced increased financial strain,** with 36% living below the ALICE Threshold, compared to 26% of veterans living without disabilities.

- **39% of Floridians under 65 with disabilities** and below the ALICE Threshold were not enrolled in Medicaid or Medicare.

- **In Florida, 59% of people with disabilities were not working,** compared to 18% of those without disabilities. Among full-time workers with disabilities, 31% earned below the ALICE Threshold.

- **For individuals aged 25+ with only a high school diploma or GED,** 54% of those with disabilities fell below the ALICE Threshold, compared to 42% without disabilities, regardless of education level.




VOLUNTEER INCOME TAX ASSISTANCE

The Volunteer Income Tax Assistance (VITA) program is a partnership between United Way and the IRS offered annually from January through Tax Day to assist families and individuals with low-to-moderate incomes prepare their tax returns for free. This year, thirty-three IRS-trained and certified volunteers ensured taxpayers received all the credits for which they were eligible and helped put an average refund of \$776 back into the pockets of Indian River County residents.

“We served more people this year than ever before, especially at a time when we know many households in our community faced financial hardships,” explained Meredith Egan, CEO, United Way of Indian River County. “It’s a milestone we’re really proud of and look forward to making that number grow each year.”

ANNUAL COMMUNITY LEADERS' BREAKFAST

On October 20th, the annual Community Leaders' Breakfast celebrated community leaders, volunteers, and the cause of affordable housing. Sponsored by Florida Power & Light Company, the event featured guest speaker, David Hall, a Florida Housing Finance Corporation Board Member, and Associate Broker with Coldwell Banker Residential Real Estate, who discussed the housing challenges faced by the ALICE population (**A**sset **L**imited, **I**ncome **C**onstrained, **E**mployed).

Meredith Egan, CEO of United Way of Indian River County, emphasized the importance of addressing affordable housing through strategic partnerships. David Hall shared insights into state-level legislation and innovations related to housing. Florida Housing has financed twenty-two affordable housing developments in Indian River County, providing over 2,400 units, and the Florida Legislature has allocated \$100 million for the Florida Hometown Heroes Housing Program.



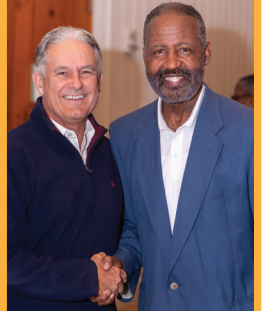

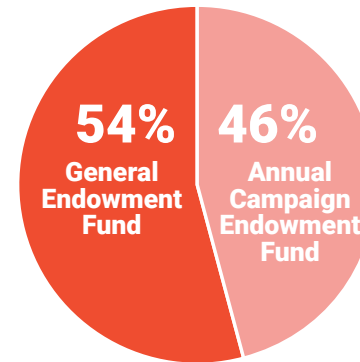
UNITED WAY FOUNDATION
